**FINAL JUDGMENT OF GARNISHMENT AS TO CITIBANK, N.A. ON ACCOUNT  
OF DEFENDANT DISTELEC DISTRIBUCIONES ELECTRONICAS, SA DE CV**

**THIS CAUSE** came before the Court upon the Plaintiff's Motion for Entry of Final Judgment Relating to Garnishee Citibank, N.A. on Account of Defendant Distelec Distribuciones Electronicas, SA de CV, c/o JF de Peyrecave, Apartado Postal #657, Tegucigalpa, Honduras ("Motion"). The Garnishee, Citibank, N.A., filed its answer and confessed that it is indebted to Defendant Distelec Distribuciones Electronicas, SA de CV ("Distelec" or "Defendant") in the amount of \$652.06. The Court, having considered the Motion and otherwise being fully advised in the premises, good cause having been shown, and no further notice or hearing appearing necessary, it is hereby:

**ORDERED AND ADJUDGED** that:


1. The Motion is hereby granted.
2. Plaintiff, TracFone Wireless, Inc., shall have and recover \$652.06 from the Garnishee, Citibank, N.A. Garnishee will remit the funds, within five (5) business days from the date of this Order, to Carlton Fields, P.A. Trust Account, Attention: James B. Baldinger, 525 Okeechobee Boulevard, Suite No. 1200, West Palm Beach, Florida 33401.

3. In accordance with FLA. STAT. §77.28, TracFone previously deposited with the Court \$100.00. The Clerk of this Court is directed to issue a payment of \$100.00, in accordance with FLA. STAT. §77.28, in favor of the Garnishee, Citibank, N.A. in care of its counsel, Louis M. Ursini, III, Esquire, Adams and Reese LLP, 101 East Kennedy Boulevard, Suite No. 4000, Tampa, Florida 33602, for responding to the Writ of Garnishment.

4. This Court retains jurisdiction to enter further orders as necessary, including, without limitation, an order authorizing execution against Garnishee, Citibank, N.A. property if this Judgment is not otherwise paid or satisfied.
